The Federation in its mandate has diligently championed its course and established an Annual Conference where different players come together to share lessons learnt, discuss challenges faced and chart a new path for the Sector.

Achievements

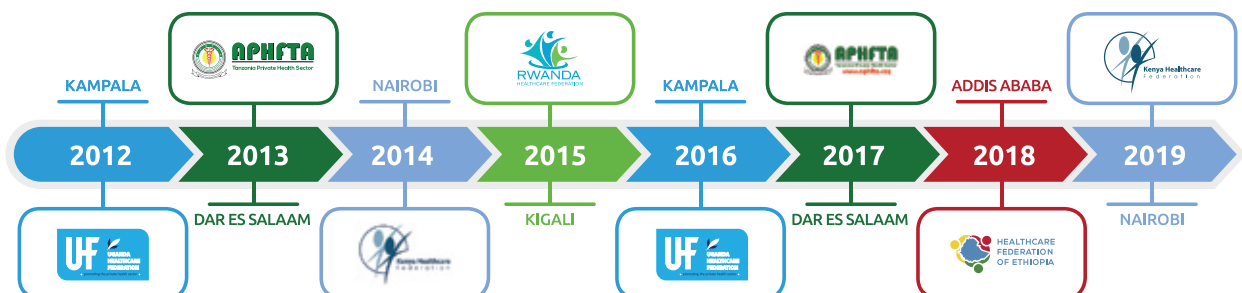
Through the last 7 years of existence, the Federation has made notable achievements:

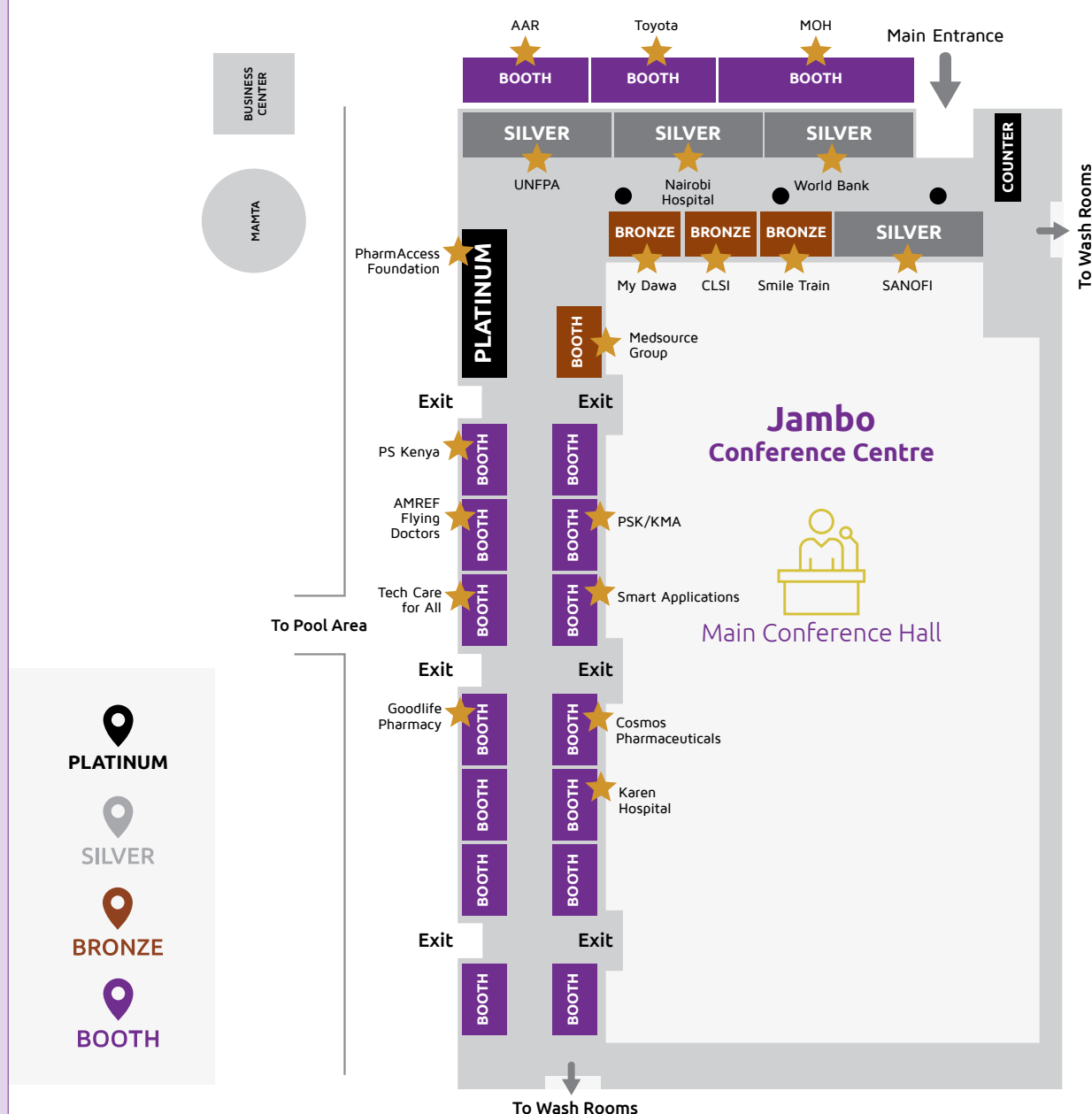
Exhibition Floor Plan
